

City of El Segundo Arts and Culture Advisory Committee

Meeting Minutes for March 28,2023 5:30 p.m.

Land Acknowledgement: We acknowledge that we are holding this meeting on the traditional, ancestral, and unceded territory of the Tongva. We recognize the Tongva people as the traditional land caretakers of Tovaangar (Los Angeles basin, So. Channel Islands). We also acknowledge that Los Angeles County is home to the largest Indigenous populations in the U.S.

A. CALL TO ORDER

1. The meeting was called to order at 5:30 p.m. by Vice Chairperson Maureen Kingsley.

C. PRESENTATIONS

1. John McCullough of the El Segundo Art Walk discusses plans for Art Walk 2023. (John McCullough/15 minutes)

John McCullough reported on the 2022 Art Walk event and shared a little about the plans for the event in 2023. The 2022 Art Walk budget was \$81k, of which \$58k was provide by the City. Public art installed as part of the 2022 Art Walk totaled \$21k of the \$58k City donation. This art includes an augmented reality installation at City Hall Plaza and Andrew Hem's mural at Labib Funk + Associates off Main Street.

As part of his presentation, John shared his vision for an augmented reality map (AR) as a tool for promoting the City's current public art. He is working on a partnership with Snap Inc. and Reality Experience Design (local company) to create this map. The estimated cost of the AR map is \$30k.

Questions from the ACC members regarding the AR map included who would own the map? if the map would only be available through the Snap App, who would get any advertising revenue generated from the map? who owns the content? Cultural Arts Coordinator Sam Lee shared his prior experience with Snap Inc regarding a current public mural in the Library. Snap did not want to sign any legal documents to work with the City in the past.

The ACC is seeking follow up for how Snap is performing as a company and who the Snap user demographics are. At this time, there is much more information needed on this proposed project.

A verbal vote was taken by Julie Todd.

MOTIONED by Chairperson Eva Sweeney and SECONDED by Natalie Strong to include the proposed Art Walk 2023 budget of \$41K in FY 23/24 initiatives to preset to Council. Motion CARRIED 11-0.

A verbal vote was taken by Julie Todd.

MOTIONED by Chairperson Eva Sweeney and SECONDED by Tanya Taylor to include the proposed Snap Map budget of \$31K in FY 23/24 initiatives to present to Council. Motion CARRIED 8-3. Members not in favor include Vice Chairperson Maureen Kingsley, Ioana Urma and Neal Von Flue.

 Acting Recreation Superintendent, Rachel Cummings discusses a possible opportunity for a Teen Center mural/signage on the exterior building. (Rachel Cummings/10 minutes)

Acting Recreation Superintendent Rachel Cummings shared about the Teen Center improvements that have taken place in 2023 and asked the ACC to consider funding a temporary mural on the Teen Center's façade as signage. Ioana Urma mentioned that the paint design process could be a more affordable option for a temporary mural. The ACC decided to identify funds from the remaining Community Engagement Fund initiative to pay for a mural on the Teen Center's façade, but the exact cost has not been determined yet based on existing program commitments with the existing balance.

MOTIONED by Chairperson Eva Sweeney and SECONDED by Vice Chairperson Maureen Kingsley to support a signage mural on the Teen Center's exterior. Motion CARRIED 11-0.

 Tanya Taylor discusses an idea to celebrate Juneteenth in El Segundo. (Tanya Taylor/15 minutes)

Tanya Taylor shared that the mission for the nonprofit Black in Mayberry is to combat racism through the arts and is looking to host a Juneteenth festival for the

first time in El Segundo. Tanya has hosted events for Juneteenth in the past. Through celebrating Juneteenth, Tanya is looking to educate communities of all backgrounds. Some of the Juneteenth activities would include a talk at ESMoA, collaboration with local schools and student unions, and a storytime at the El Segundo Public Library. She is meeting on Thursday with City staff to discuss the event and is looking for support from the ACC as well.

Councilmember Giroux asked about Tanya's timeline in relation to the school district's end of year timeline – if they will be in session.

Eva is in favor of the ACC supporting a Juneteenth program.

Joanna Bowe suggested funding the cultural elements of the event such as performers. The ACC is asking Tanya to present a more detailed budget for further discussion.

D. PUBLIC COMMUNICATIONS

Councilmember Pirsztuk clarified her thoughts on the ACC's plan. She wants to see funds put aside for City CIP's and is looking to have the ACC grant money to the Old Town Music Hall, the Zimmerman Automobile Museum, and ESMoA for programming within the City. She is concerned about the recession and how the Cultural Development fund will be sustained in the coming years.

Chairperson Eva Sweeney would like to include CIP's in the budget for the 23/24 FY. Brian Mitchell is requesting a priority list of CIP projects before deciding on a budget. Chairperson Eva Sweeney is asking that the ACC be informed about new development projects in the City in order to be more proactive.

Councilmember Pirsztuk is asking that the ACC create a grants initiative for local cultural non-profits. Neal Von Flue and Councilmember Giroux confirmed that there is not enough time before the 23/24 FY budget to develop a grant program for FY 23-24.

Chairperson Eva Sweeney suggested creating funding for the three cultural non-profits in town to run for the next fiscal year.

The ACC's proposed new budget won't be presented to Council until the first meeting in May, moved from the April 18th meeting. Discussion about scheduling a Special Meeting of the ACC sooner, rather than on the regular scheduled fourth Tuesday took place. This would allow the committee to meet sooner to discuss the 23/24 FY proposed initiatives.
